Morning: Handicap match play – two flights – semi finals

Afternoon: Handicap match play – finals

Entries to be made in pairs. Entry forms can be obtained from the Competitors' Club Secretary or downloaded from the NCGU website, [www.norfolkcountygolfunion.co.uk](http://www.norfolkcountygolfunion.co.uk). All forms must be signed by the Competitors' Club Secretary unless the players' correct CDH Lifetime ID Numbers are filled in on the entry form. **Entrance Fees must be sent with entry forms.**

All competitors must have an active handicap not exceeding 12 during the period of entries above.

**Entries may be limited at the discretion of the Committee.** If entries exceed the limit, pairs with highest aggregate exact handicaps will be eliminated, by ballot if necessary.

Conditions as to qualification to compete in County Union Competitions can be obtained from the Competitors' Club Secretary, and are shown in Regulations 2.8 in the County Union Handbook.

Ties in the qualifying rounds will be decided on the last 18, 9, 6 or 3 holes.

Matches all square at the end of the round will be continued until one side wins a hole, strokes being taken as they originally occurred.

**All competitors are reminded that the qualifying competition is 36 holes and that they are expected to complete both rounds. Anyone failing to do so without an acceptable reason could be subject to disciplinary action.**

The decision of the Committee in all matters relating to this Competition shall be final.
